The following Classes of Membership are offered by the ECC -

## **“GENERAL CONTRACTOR”**

General Contractors who employ tradeworkers from Unions with whom the ECC bargains collectively.

## **“SUBCONTRACTOR”**

Subcontractors who employ tradeworkers from Unions with whom the ECC bargains collectively. (Bricklayers, Carpenters, Cement Masons, Plasterers, Painters/Drywall Finishers, Roofers, Laborers, Operating Engineers)

## **“ASSOCIATE – SUBCONTRACTOR”**

Subcontractors who employ Union tradeworkers from Unions with whom the ECC does not bargain collectively. (Electrical, Sheet Metal, Plumbing, HVAC, Glazing, Steel, Teamsters, Tile)

## **“ASSOCIATE - SUPPLIER”**

Firms who supply materials and equipment to Contractors and Subcontractors.

## **“ASSOCIATE - OTHER”**

Insurance companies, financial institutions, consultants, architects, engineers, or any other service or activity involved in the construction industry.

## **“HONORARY”**

Individuals or companies who have been recognized by the ECC for long meritorious service and support of the organization.
